AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Grays Harbor County from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- General revenues and expenditures
- Financial condition
- Procurement – public works
- Payroll
- Utility billing
- General disbursements
- Significant internal control systems:
cash receipting and accounts
receivable

INFORMATION ABOUT THE DISTRICT

Public Utility District No. 1 of Grays Harbor County is a publicly owned electric utility with approximately 41,500 customers. It provides electric energy services to homes, businesses and industries throughout Grays Harbor County. The District offers programs to help customers use energy efficiently and supports policies that promote natural resource conservation.

An elected, three-member Board of Commissioners governs the District. Board Members serve staggered, six-year terms. The Board appoints a General Manager to administer the District's day-to-day operations and its 162 employees. The District operates on a \$120 million annual budget, of which approximately \$75 million is used to purchase electric power for its customers.
